1. Full Member: Membership in any 2 leagues (or more if space available)
2. One Evening: Membership in one evening league:

 - b. Wednesday Business Women's League; **OR**
 - c. Friday Mixed League - for male and female curlers; **OR**
 - d. Individual playing as a fifth person on a team
3. Day Curling: Membership in the Day Ladies League **OR** the Day Men's League **OR** the Day Mixed League Monday to Friday, 9:00 a.m. to 5:00 p.m., with no limit on the number of daytime curling events per league
4. Junior Program: Sunday - 12:30 p.m. to 3:00 p.m. for youth and young adults - ages 13 to 20 (20 or under on December 31, 2014)
5. Little Rocks Program: Sunday - 3:00 p.m. to 5:00 p.m. for children ages 7 to 12
